NAS-ISHR MID-CAREER COMMITTEE (NAS-ISHR-MCI8+)

Leadership Achievement Award

Nominations Due March 31, 2023

MCI Leadership Achievement Award: (One award; winner)

The purpose of this Award is to recognize an outstanding mid-career scientist who is making major and independent contributions to the advancement of cardiovascular science, and leading a growing research program likely to play a significant role in the future. The main criteria for selecting awardees are scientific excellence, research contributions, mentoring, leadership and service to the cardiovascular community. The MCI Leadership Achievement Award is presented at the NAS ISHR annual meeting to an investigator in the intermediate phase of an established academic career. The awardee will present a major lecture, will receive a \$1,000 honorarium and a plaque, and will be featured in JMCC.

Nature of the Prize

The Outstanding Mid-Career Investigator Award is presented at the NAS ISHR annual meeting. The awardee will present a major lecture, and will receive a \$1,000 honorarium and a plaque. An announcement of this Award, along with a photograph and a short bio, will be published in Heart News and Views and posted on the ISHR website. The Award includes free meeting registration for the meeting.

Eligibility

The applicants must be an active member of NAS-ISHR with an MCI- affiliation. All Associate professors, or Assistant Professors with >5 years after their first faculty appointment (who are not ECIs or ISHR-ECI members (>8 years from their terminal degree- e.g. PhD or MD) by June 1, 2023 are eligible to be nominated. Full Professors will not be considered for this award.

Procedure for Nomination and Selection

1. Nominations for the MCI Leadership Achievement Award will be sought and administered by the Chair of the NAS Mid-Career Committee, and the NAS Leadership Council of ISHR
2. Nominees and nominators must be active members of the International Society for Heart Research (ISHR) at the time of nomination. Please contact Dr. Maria Kontaridis at kellybrodsky.ishrnsa@gmail.com for membership questions.
4. Nominations will be evaluated by a multidisciplinary Selection Committee composed of members of the NAS Leadership Committee. All NAS-MCI members may apply for this Award.
5. Members of the Selection Committee will declare any conflict of interest (or close relationship with any candidate) and the voting mechanism will be adjusted accordingly.

6. The Award carries with it the requirement to attend the ISHR meeting at which the award is presented.

9. **Requirements:** Nominations (one per person) must include the following materials, with all documents submitted electronically as a single PDF:

- 1. A nomination letter (maximum two pages) confirming the nominee's commitment to attend the relevant ISHR meeting, if elected, and describing the nominee's research contributions and leadership achievements. Letters proposing a nomination are most helpful if they deal as specifically as possible with the candidate's most important contributions to science, as well as outlining any significant career breaks. Administrative service or leadership will be considered by the Selection Committee.
- 2. Nominee's current curriculum vitae containing the following:

A statement from the candidate that includes:

- i. Confirmation that they will attend the meeting and present their research;
- ii. Provide a justification for their nomination and summary of their achievement

The CV should include the following sections:

- i. Position and appointment
- ii. Awards/honors
- iii. Scientific accomplishments (with top 5 publications highlighted), all publications with citations, Hi Index
- iv. Mentoring, mentee achievements, contributions to diversity and inclusion
- v. National and International recognition and service (committees and other professional achievements)

Full CV should be included- there is no page limit

10. Any members of the ISHR-NAS MCI or leadership committee may submit a nomination (maximum nominations submitted one per member)

11. Self-nominations will not be considered.
